What is this product?

Type: This product is a non-UCITS investment fund.

Objectives: The investment objective of the Fund is to invest in above average yielding assets while achieving long term capital growth and maintaining an adequate spread of risk by investing in equities of companies incorporated in those member states of the European Union who are also members of the European Monetary Union (Eurozone) and are listed or traded on Recognised Exchanges in Europe. The Fund has an overriding ethical screen overlaying the portfolio and which is managed by the Investment Manager. If a particular stock does not meet the relevant ethical criteria laid down by the Investment Manager, then the Fund will not invest in such stock.

Intended investor: This product is intended for investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed to form part of a portfolio of investments.

Maturity: This product is open ended.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
