### What is this product?

**Type:** This product is a non-UCITS investment fund.

**Objectives:** The investment objective of the Fund is to achieve long term capital growth while maintaining an adequate spread of risk. The Fund aims to offer significant diversification by gaining exposure to alternative assets and themes/sectors, including but not limited to commodities, alternative energy, water and emerging markets, not normally available in traditional equity or managed funds. The performance of the Sub-Fund will be measured against the MSCI World Index.

**Intended investor:** This product is intended for investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed to form part of a portfolio of investments.

**Maturity:** This product is open ended.

## What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

## What are the costs?
