What is this product?

Type: This product is a non-UCITS investment fund.


Objectives: The aim of the Fund is to achieve long-term capital growth and has been established for the purpose of marketing to charities. The Fund seeks to achieve its objective through investment directly and/or indirectly in a broad range of bonds and Irish and international equities listed or traded on Recognised Exchanges worldwide. The asset mix will reflect the Investment Manager's investment outlook at any time, subject to a maximum equity weighting of 80% of the overall portfolio. All actively managed fixed interest and listed equity holdings, including actively managed collective investment schemes in which the Fund invests, are passed through the Investment Manager's ethical screening process before being added to the Fund.

Intended This product is intended for investors who are prepared to take on a relatively high level of risk of investor: loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed to form part of a portfolio of investments.

Maturity: This product is open ended.



What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products.
